The application is for a takeaway to be open to the public from 6pm until 2am the following day. The application requests the sale of alcohol for the times to reflect the opening hours and late night refreshment to allow the sale of hot food and drinks from 11pm until 2am the following day, all the times are to cover Monday to Sunday.

The applicant, Mr David Mattis described in box K details that the premises intends to be primarily a fast food outlet with selective alcohol sales only.

The Premises are located on Outram Street which is within Sutton Town Centre and a main thoroughfare for the town.

Outram Street is made up of several different retail premises, of those there are a number of licensed premises which includes 5 restaurants with a takeaway service, 4 public houses, 5 off licences, a florist with a alcohol licence and 4 late night refreshment venues known as takeaways.

These premises already cater for sit down meals, alcohol, dancing and takeaway food.

it is the view of Nottinghamshire Police that this part of the town has adequate provisions for takeaways and off licence premises, although Ashfield District Councils statement of licensing policy states (7.28) that there is no Cumulative Impact policy currently in place, it also states that there is potential for a change in this situation. Nottinghamshire Police do not feel the area is yet to a point of saturation, but we do feel that that any additional premise licences granted within this immediate area need to be carefully and individually considered and conditioned to ensure they promote the licensing objectives and as in 2.8 of the Councils statement of licensing policy, do not have a negative impact on members of the public who live and work within that area.

Having had regard to the nature, style and location of the premises, the Police have concerns over the increase in alcohol related anti-social behaviour, crime, disorder and nuisance that the grant of this premises licence will cause.

The very style and nature of a late night pubs and takeaways creates problems of crime and disorder. These types of venues attract patrons later in the evening, many of whom have been drinking alcohol in the pubs and bars within the town centre. People have a tendency to become more disorderly and anti-social as the night progresses on account that they become increasingly intoxicated and therefore prone to engage in disruptive behaviour.

Ashfield District Council's statement of licensing policy states at 2.1 in exercising their functions under the licensing act 2003, licensing authorities must have regard to the licensing objectives as set out in section 4 of the act.

Ashfield District Council's policy also states at 2.6 the promotion of the licensing objectives is paramount consideration for the authority.

Ashfield District Councils Statement of licensing policy states at 5.2 that in the Licensing Authority are to remain impartial but in exceptional

circumstances they can take on the role of a responsible authority. Nottinghamshire Police has been informed by Ashfield District Council Licensing Section that the applicant has agreed to some conditions proposed by Ashfield District Council in the form of a document called 'Operational Policies'.

Some of the conditions within 'Operational Policies' do address issues that Nottinghamshire Police would have requested become conditions, CCTV in particular and a Challenge 25 policy to tackle underage sales of alcohol. However, we are of the opinion that this application in its entirety does not promote the licensing objectives, in particular the prevention of crime and disorder, and will add to the negative impact already experienced in Sutton Town Centre in respect of the later times requested for licensable activity to take place, mainly the sale of alcohol.

Nottinghamshire Police would like to see the operating schedule address alcohol sales, and how the applicant will ensure that the premises is predominantly food led as stipulated within the application form in box K.

It is a concern of Nottinghamshire police that a member of the public could leave a local public house and purchase alcohol in the early hours from this premises without the necessity of a food purchase. We do not want to restrict business by requesting alcohol sales are for home delivery only, but instead would like alcohol to accompany food.

Nottinghamshire Police has had contact with Mr Mattis to request a condition be placed upon the licence, unfortunately Mr Mattis declined the condition, he felt that 'due to the fact we have already accepted without cause, addition(sic) stipulations which add to our running costs. Hence. With respect I reject this condition. As no other takeaway I know of has a minimum price for selling food'.

In view of this and the interests of the wider community, it is the opinion of the Police that the only way that this premises will not have a negative effect, and will not undermine the licensing objectives, is if the condition below is placed on the premise licence.



I am a Police Inspector with Nottinghamshire Police currently based at the Kirkby Integrated Partnership Hub, Ashfield District Council, Urban Road, Kirkby In Ashfield. I am the District Commander for the Ashfield District which includes Sutton In Ashfield.

I have been an officer within Nottinghamshire Police for over fifteen years and as a result I am fully conversant with the issues of crime and anti social behaviour that have been, and continue to be, addressed by partners, stakeholders, the community and those within the policing family.

As the District Commander I am responsible for managing the policing response to crime and disorder within the district. This includes identifying crime trends of and working with partners across the community safety partnership to set policing priorities. These priorities are set by analysing police incidents and intelligence on a daily basis and comparing these with concerns regularly raised by the local community. It is my aim to set policing strategies that help Nottinghamshire Police to deliver a service that works for local people, with my primary focus being to keep people safe. As a result I have an interest in the operation of all the licensed premises within in the district, particularly those where the sale of alcohol contributes to the high levels of crime, disorder, anti social behaviour and public nuisance that exists within that and adjacent communities.

I have been made aware than an application has been submitted for a premise licence to be granted for 127 Outram Street, Sutton In Ashfield, Nottinghamshire, NG17 4BG. It is my understanding that the applicant, Mr MATTIS seeks to use it as a fast food takeaway, with the additional facility to also serve alcohol.

Outram Street runs from the town centre and through the heart of the New Cross area. It is already host to a high number of licenced premises and food outlets and in a recent analysis of

policing demand in Ashfield, it was found to be one of the five highest streets for police incidents, attracting approximately 800 calls between 1st August 2018 and 31st July 2019.

Sutton in Ashfield presents significant policing challenges. The town features within top five neighbourhoods in Nottinghamshire for anti-social behaviour, violence and domestic abuse and as a result I am currently leading multi-agency problem solving plans in the areas of the town centre and the New Cross area.

These plans include representatives from across the Police, District Council and community and have been used to target the crime types identified previously and have so far been successful in reducing problems there. This is thanks to tactics including increased patrols, increased alcohol licencing checks and work targeting persistent offenders. It appears from our problem solving activities that have been taken that there is a clear link between alcohol misuse, anti-social behaviour and violent crime. When considering this in view of the existing problems in the area and having considered the nature, style and location of the intended premise, I have serious concerns that the granting of the application will:

- a) have a negative effect on the community
- b) have a negative impact on the already significantly high levels of anti-social behaviour, crime, disorder and nuisance; and
- c) undermine what we and our partners are trying to achieve

I understand Mr MATTIS has agreed to have CCTV installed and operational, amongst other conditions however, I cannot support the application in its submission and it is my considered opinion I respectfully recommend that the application be supported by an additional condition to limit and restrict alcohol sales without the purchase of food, with a minimum food cost being £5 for reasons outlined above

- 3. I had been informed by Julian Alison, Licensing Team Leader at Ashfield District Council that the applicant had agreed to their 'Operational Policies', and through my experience of working with Mr Alison I was aware of this document, and some of the conditions that it included. The only conditions I felt necessary from a prevention of crime and disorder perspective to be applied to the licence were around CCTV, a Challenge 25 scheme to prevent underage sales, and a minimum pricing on food in order to be able to purchase alcohol; to prevent alcohol only sales and encourage a larger amount of food to be purchased. These conditions are mostly covered within Operational policies. Due the Mr Mattis stating in box K of the application form 'Premises would be operating primarily as a fast-food outlet with selective alcoholic sales only' I was of the opinion that the conditions I wanted to propose would be relevant and support the applicants statement that alcohol will be selective and food will be the primary purpose.
- 4. On 24th June 2019 I received an email from Julian Alison to Mr David Mattis proposing conditions be added upon the premises licence at the request of Mr Alison as a responsible Authority, along with a copy of those conditions that were not in the familiar style of the Operational policies, but rather an attachment and list of conditions. Mr Mattis replied to Mr Alison and myself the following day agreeing to those conditions. This is attached for your information as CA01.
- 5. On 18th July 2019 I emailed Mr Mattis to confirm Nottinghamshire Police had received his application form and that I wanted to propose a further condition. I have provided a copy of this email and a reply from Mr Mattis that I received the following day declining the proposal. This is provided as CA02.
- 6. Although the Mr Mattis had already accepted a condition with Mr Alison similar to the one I requested, I felt it necessary to make the condition more specific to place additional control measures on the sale of alcohol. The condition proposed by Mr Alison is as follows:

'The sale of alcohol shall be restricted solely to such persons purchasing late night refreshment from the premises'.

It is the opinion of Nottinghamshire Police, that this condition is not specific enough. It is feared that a customer could purchase a small amount of food, for example a cone of chips, a naan bread etc at a small cost so that they were able to purchase alcohol when most of the other premises selling alcohol in the vicinity are closed. Nottinghamshire Police believe that if a minimum food purchase price of £5 was instigated, this would discourage and prevent sales to those individuals who are mainly interested in purchasing alcohol and not food when leaving local licensed premises. The nearest Public House is the New Cross, which has a licence to serve alcohol until 0100 on a Saturday and Sunday. It is a concern of Nottinghamshire Police that individuals could leave the New Cross and go to this premises to purchase additional alcohol to continue drinking in the street, this has the potential to cause disruption to local residents as they would be under the influence of alcohol and have the potential to commit crime and/or disorder, further being a detriment to the area. By having the condition proposed by Nottinghamshire Police upon the licence, customers would be purchasing a larger amount of food, therefore upon leaving the takeaway will likely either be eating a more substantial food purchase or be more inclined to go home sooner to eat the food they have purchased before it goes cold. A table of times for other premises in the locality is attached for reference as CA03.

- Nottinghamshire Police is confident the condition we have proposed has the same enforceability as the one agreed by Mr Mattis from Ashfield District Council. This condition has been agreed by other applicants, and placed on premise Licences in other parts of the county, an example of this is a licence issued by Mansfield District Council which I have provided as CA04.
- 8. Nottinghamshire Police, along with partners, have a responsibility to ensure Sutton Town Centre is not only vibrant but is an environment that is safe, and only by licensed venues promoting the four licensing objectives, can crime and disorder be minimised. Nottinghamshire Police is aware that some conditions may restrict lawful business by

1. A CCTV system with recording equipment shall be installed prior to the premises carrying out licensable activities and maintained in accordance with the scheme.

All recordings used in conjunction with CCTV shall:

- be of evidential quality
- indicate the time and date
- be retained for a period of 31 days

Recordings shall be made available for inspection when requested by the Police or any other authorised person.

- 2. The sale of alcohol shall be restricted solely to such persons purchasing late night refreshment from the premises.
- 3. The Premises Licence holder shall ensure that a dedicated area is provided for vulnerable patrons (i.e. through alcohol, drugs isolation, underage, etc.) that have come to the attention of staff employed at the premises. This area will be for the safeguarding and appropriate support and first aid (if required) of such persons.
- 4. The Premises Licence Holder shall ensure that all staff employed at the premises whose duties include the sale or supply of alcohol shall undertake and complete a relevant programme of training prior to them being authorised to sell or supply alcohol. Such training shall consist of providing staff with an understanding of:
 - The need to ensure the responsible sale and supply of alcohol
 - The need to refuse the sale and supply of alcohol to persons who are intoxicated or underage
 - The need to seek credible age verification from persons seeking to be sold of supplied alcohol who may appear under the age of 18 years old

Records of the training programme shall be maintained and made available to Authorised Officers upon request.

The Premises Licence holder shall provide a "refresher" training session to all relevant staff members as and when deemed necessary on a case by case evaluation, but as a minimum requirement the refresher training session shall be provided to all staff on at least one occasion every six months.

- 5. A Premises Daily Register shall be held at the premises. This Register shall be maintained for a rolling minimum period of 12 months, and shall record:
 - The name of the person responsible for the premises on each given day.

 - All calls made to the premises where there is a complaint made by a
 resident or neighbour of noise, nuisance or anti-social behaviour by
 persons attending or leaving the premises. This shall record the details of

 Any refusals on grounds of age and/or intoxication (to include date, time, member of staff involved, reason for refusal as well as a brief physical description of the person refused)

Any calls to or visits by Nottinghamshire Police or the Licensing Authority in relation to any crime and disorder / public nuisance or like related matter.

The Designated Premises Supervisor shall check the Premises Daily Register on a weekly basis ensuring that it is completed and up-to-date, sign the Premises Daily Register each time that it is checked, and make the Premises Daily Register available for inspection by any Authorised Officer throughout the trading hours of the premises.

- 6. The Premises Licence holder shall participate in the designated local Pubwatch / Licensed Premises Partnership scheme (should one be in operation) and ensure that a representative of the licensed premises attend all of the arranged meetings or such a person has made all reasonable endeavours to attend the arranged meetings.
- 7. Prominent, clear notices shall be displayed at all exit points to advise customers to respect the needs of the local community and of acceptable behaviour in public spaces.
- 8. Signage shall be displayed advising customers to be respectful to residents and to leave the area in a quiet and orderly manner.
- 9. Waste receptacles shall be provided in the external areas immediately outside of the premises for customer to deposit any waste material relating to their purchase of late night refreshment from the premises.
- 10. Challenge 25 notices shall be displayed in prominent positions throughout the premises.

- A CCTV system with recording equipment shall be maintained at the premises and operated with cameras in positions agreed with the Police. All recordings used in conjunction with CCTV shall:
 - Be of evidential quality
 - Indicate the time and date
 - Be retained for a period of 31 days
 - Sufficient staff will be trained to use the system
 - The images will be made available for inspection immediately upon request to officers of Responsible Authorities.
- The sale of alcohol shall be restricted to those placing an order for food, either by telephone
 or in person at the premises for home delivery only. The value of the food will be in excess of
 £5.00
- 3. All deliveries of alcohol will be recorded in a legible written log.

The log will:

- be in possession of the delivery person and their details be recorded in the log
- Identify the name and address of the person placing the order
- Identify the delivery address and the details of the person receiving the alcohol
- Identify the time and date of delivery and the details of what was delivered
- If recipient was believed to be under 25 at point of delivery, details of identification shown to satisfy the supply of alcohol

The log will be retained for a period of 12 months and made available for immediate inspection when requested by any person of a responsible authority.

The Prevention of Public Nuisance

1. Prominent, clear and legible notices shall be displayed at all exits requesting the public respect the needs of local residents and to leave the premises and area quietly.
