



FORWARD PLAN OF EXECUTIVE DECISIONS FOR THE PERIOD November 2022 - February 2023

- (a) Result in the Council spending or making savings of over **£50,000 revenue** or **£1m capital**, or;

The plan also lists those 'Exempt' Decisions' which are going to be taken over the next four months. Exempt Decisions are those decisions which have to be taken in private. This is because they involve confidential or exempt information which cannot be shared with the public.
