Due to the specialist, large scale, nature of the work in question, this is unable to be completed using our own employees.

6. Implications

Legal

The Council has the power to enter into contract in order to discharge its functions (Local Government Act, s111 and the Local Government (Contracts) Act 1997, s1).

The Local Government Act 1972 requires the Council to have regulations for how it enters into contracts. In addition to complying with all relevant UK legislation every contract entered into on behalf of the Council must also comply with the Council's Contract Procedure Rules and the Council's Financial Regulations. <u>Finance</u>

The submitted tender is within the proposed 2022/23 budget and will be maintained for the duration of the contract period. The procurement exercise was to get the best value for ADC. The values of this contract will be reviewed in the financial year and managed into the overall Major Works Aids and Adaptation budget. (PH 09/05/2022)

The Sub-contractor would be engaged by the Council for the specific works, these would not be employees of the Authority, however, the Authority must ensure that we are compliant with IR35 regulations. (KB 09/05/2022)
