In accordance with Government requirements, a Discretionary Scheme to pay households not in Bands A-D has been designed. The design of the scheme takes into consideration the value of funding provided by the Government and where we should target payments to those most in need in Band E to H properties only.

Households in Band E properties and a household in a property Band E to H who is in receipt of a Council Tax Reduction (CTR) will be eligible for the £150 rebate.

Any household in a Band F, G or H property and in receipt of benefits is eligible to apply for a £150 rebate.

Any household in a Band F, G or H property whose (joint) annual income is less than \pounds 31,400 and/or their savings and investments is less than \pounds 16,000 is eligible to apply for a £150 rebate.

	Where a resident was in a Band E to H property within the District as at 1 st April and has since moved to a Band A to D property within the District and has not received the Council Tax rebate, the £150 rebate will also be paid.
4.	Reasons for the Decision: Again, briefly explain why you thought this was the right decision To utilise the funding provided by the Government specifically for this purpose and to target those most in need of financial support who have not already received support through the main Council Tax Rebate payments (Band A to D).
