### Please state the ground(s) for review (please read guidance note 2)

Nottinghamshire Police Licensing Officers have recently visited the premises on two occasions. These visits have identified serious concerns that the premise Licence holder and Designated premise supervisor Ravidu Hewa WADUGE is not able to safely and legally operate the premises. This has resulted in verbal and written warnings being issued to WADEGE.

Nottinghamshire Trading Standards have also recently visited the premises on two occasions. This has resulted in the seizure of counterfeit vapes and cigarettes on both occasions, along with suspected counterfeit alcohol and cannabis-based confectionary. Police have also seized three large knives from behind the counter.

There has also been reports from concerned residents alleging sale of vapes and alcohol to under 18's. On 14/11/2022 a third and final test purchase operation took place at the premise resulting in a vape being sold to an underage person.

On 15/11/2022 Nottinghamshire Police issued a Closure Notice to WADUGE advising Nottinghamshire Police are attending Mansfield Magistrates Court 17/11/2022 to request a Closure Order is granted, ensuring the premise is closed

Nottinghamshire Police have no confidence in the management to ensure that the licensing objectives are promoted, in fact they are undermined to such extent that it is the opinion on Nottinghamshire Police that by having a licence is a risk to the public.

Please provide as much information as possible to support the application (please read guidance note 3)

The licensing objectives of the prevention of crime and disorder, public safety and protection of children from harm have all been undermined at this venue.

The premises are situated in Stanton Hill, Sutton In Ashfield with a premises licence that allows the sale of alcohol off the premises, from 07:00 – 23:00.

Ravidu Hewa WADEGE is both the Premises Licence Holder and Designated Premises Supervisor.

Summary of incidents and visits of note (further comments are included in the Police evidence bundle).

10/05/2022 – Intelligence received that the shop is regularly selling vapes to under 16 year old and alcohol to under 18's

16/08/2022 - intelligence reports alleging the owner selling cannabis from the premises

20/11/2021 – Test purchase took place at the premises. The young person was able to purchase a large kitchen knife without challenge from WADUGE. A case file was constructed, tasked through to their supervisor before being sent through to Notts initial files. The process limit was exceeded so no charges made, and case was closed 06/06/22.

### Visits/Inspections

19/08/2022 —Compliance visit by Adrian PALING, Nottinghamshire Police Licensing Officer. Premises were non-compliant on the conditions of the premise licence, namely: CCTV access, Challenge 25 policy and Staff Training. As part of that visit, counterfeit cigarettes were identified, and Trading Standards made aware. The staff members were told these are not allowed to be sold as are non-compliant and would be reported to Trading Standards. (Ravidu Hewa WADEGE was out of the country on this date)

01/09//2022 –Re-visit by Adrian PALING, Nottinghamshire Police Licensing Officer to check compliance from previous breaches identified. Premises were again found to be non-compliant on the conditions of the premise licence, namely: CCTV access and retention periods of footage, Challenge 25 policy and Staff Training. Ravidu Hewa WADEGE was present at this visit. It was also noted that the vapes display showed a brand on-sale that had been identified as non-compliant (ELUX) This was raised to Trading Standards as intelligence to support an inspection.

06/09/2022 – Visit by Police and Nottinghamshire Trading Standards, resulting in seizure of circa 1400 non-compliant vapes and 30 packs of counterfeit cigarettes.

05/10/2022 — Visit by Police and Nottinghamshire Trading Standards, resulting in seizure of non-compliant vapes. Also seized were over 20 bottles of vodka believed to be counterfeit, 16 packets of cannabis infused confectionary and three large knives which had been seized from the top of the cigarette counter.

14/11/2022 - Third Test Purchase Op by Nottinghamshire Police - Outcome - FAIL. 16 year old able to purchase vapes

15/11/2022 – Search by Trading Standards/Nottinghamshire Police – A further 100 non-compliant vapes were identified on the premises

15/11/2022 – Issuance of Closure Notice by Nottinghamshire Police to Ravidu Hewa WADEGE with immediate effect

17/11/2022 – Pre-arranged court date for request of a Closure Order for Buy and Save, Stanton Hill which will request closure of the premises for three months

### Summary

Due to the nature of incidents, and the repeated seizure of counterfeit vapes/cigarettes and alcohol at the premises, the Police have concerns that the management of the premise is wholly undermining the licensing objectives. Ravidu Hewa WADUGE has shown complete disregard for authority and has continued to openly sell counterfeit goods despite clear stern advice and warnings from both Police Licensing officers and Trading Standards officers. The lack of staff training in relation to alcohol sales demonstrates poor management and a real risk to children.

The Police support premises and encourage well managed, safe premise to thrive. WADUGE has demonstrated a disregard for the licensing objectives and licence conditions despite support and advice being given on numerous occasions.

Nottinghamshire Police believe in order to rectify the issues surrounding crime and disorder is to ask for a full revocation of the premise licence with immediate effect, along with consideration being given to the suitability of Ravidu Hewa WADUGE holding a personal licence.

- 1. I am the Police Licensing Enforcement Officer for Mansfield and Ashfield areas, and I am based at Mansfield Police Station. My role is to monitor incidents and liaise with designated premises supervisors, premises licence holders, door supervisors and partner agencies to try to reduce alcohol related violence and disorder incidents within licensed premises. I have been employed in this role since June 2021.
- 2. I make this statement in respect of, and in support of an application by Nottinghamshire Police to make a formal representation to review this premise following visits by officers from Nottinghamshire Police and Nottinghamshire Trading Standards. On these visits to the premises, it has highlighted poor management in relation to the Premise Licence conditions, along with counterfeit cigarettes and vapes being identified and located on sale at Buy and Save, 7 High Street, Stanton Hill, Sutton in Ashfield, NG17 3GG. The Designated Premise Supervisor and Premise Licence Holder is Ravidu Hewa WADUGE.
- Nottinghamshire Police were made aware of a report on 10th May 2022 from a local resident suggesting that the shop is selling vapes and alcohol to under 18's. Sutton in Ashfield Neighbourhood Policing Team were made aware of this. As a result, positive action was taken and a test purchase operation was held in the Ashfield area on 23rd June 2022, whereby a male under 18 attempted to buy alcohol. The premise did refuse the sale on this date.
- Nottinghamshire Police were made aware of a report on 16th August 2022 from a local 4. resident suggesting that the shop is selling cannabis from the premises. Sutton in Ashfield Neighbourhood Policing Team were also made aware of this.
- I am also aware of an operation held by Sutton in Ashfield Neighbourhood Policing Team 5. on 20th November 2021, whereby a young police cadet aged 15 was working with the police and was tasked with going into Buy and Save, Stanton Hill to try and purchase a knife. The

cadet was able to purchase a large kitchen knife without challenge from the shop keeper. The shop keeper has been named as Ravidu Ashan Mewa WADUGE. A case file was constructed but no charges were made.

I made an unannounced compliance visit at Buy and Save on Friday 19 August 2022 at 11:25 with the intention of doing a compliance audit with the owner (DPS and PLH) Ravidu WADEGE. On arrival I was greeted by a female shop worker Latha Fernando Gardi HEWAGE and a male shop worker who identified himself as the shop manager, Gelhore RAYMOND. I was advised the shop owner Ravidu Hewa WADUGE was on holiday and out of the country. Compliance tests were still done in the absence of the owner, who was contacted via telephone by one of the staff and I talked to Ravidu Hewa WADUGE to say I would be completing a compliance visit.

Failings identified as part of the visit, which are in breach of premise licence conditions, are shown below.

CCTV not accessible by staff, so could not verify retention period. It is noted they have a decent system with cameras in and outside

Challenge 25 posters not on display,

Premise licence summary not on display

Staff training documents not available and Gelhore RAYMOND stated he has not signed anything for staff training, indicating that training has not been documented.

I then looked around the store and the storerooms and noted lots of spare stock in there but no cigarettes. I asked Gelhore RAYMOND where they kept cigarettes and he said it was kept at the owners house or at his Aunt's house. Gelhore RAYMOND did not disclose the addresses.

I looked behind the counter and the display cupboard where they sell cigarettes. I noticed on the top right side of the cupboard some blue packets of cigarettes. I took these out and there were nine (9) sealed packets of the blue Richmond King size 20's, which are not of current design, which I believed to be counterfeit. I asked why they were there and Gelhore RAYMOND indicated he did not know. I said these are not to be sold and to remove immediately, which was done in my presence. I stated that I would be reporting the shop to Trading Standards and there will be consequences from that.

- 8. I refer to exhibit AP2 which are photographs of the sealed packets of Richmond King size 20's which I believed to be counterfeit
- 9.. I refer to exhibit AP3 which is an email to Trading Standards on 22<sup>nd</sup> August 2022 reporting my findings in relation to the Richmond King size 20's which I believed to be counterfeit

- 10. I refer to exhibit AP4 which is a copy of the written warning letter sent to Ravidu Hewa WADUGE on 22<sup>nd</sup> August 2022 formally identifying the conditions that were not met and requesting that these are addressed within seven (7) days. This letter was emailed to Ravidu Hewa WADUGE and a hard copy posted to the premise address.
- On 01st September 2022 at 15:00 I made a repeat unannounced visit to Buy and Save 11. to check if breaches identified previously had been addressed. Ravidu Hewa WADUGE was not in on arrival, however the shop manager Gelhore RAYMOND contacted Ravidu Hewa WADUGE who came to the premises within ten minutes.

I discussed the reasons for my initial visit (at initial visit Ravidu Hewa WADUGE was on holiday but I did speak by phone to him) The original visit had a compliance letter sent by email to an email address held on file (which bounced back as undeliverable) and a hard copy posted to premises. Ravidu Hewa WADUGE then gave an updated email address and stated that a hard copy of the letter has not been received.

I explained the breaches identified at that visit regarding CCTV, staff training and Challenge 25. It is noted that a Challenge 25 poster is now on display in the front window.

Ravidu Hewa WADUGE logged into the CCTV system, and it was confirmed that the system only records for two (2) weeks, so not in line with 31 days as per license. No staff training records were on hand.

I advised I would resend the original warning letter plus one from today specific to CCTV and staff training and would do another unannounced visit at some point in the future. I also signposted Ravidu Hewa WADUGE to National Pubwatch website and/or to contact Ashfield District Council for draft working policies that could be used to support staff training. I also asked Ravidu Hewa WADUGE to contact the CCTV installer to ensure the hard drive is capable of recording 31 days, offering a suggestion that some cameras may be amended to 'motion-only' which could free up memory capacity instead of recording 24 hours a day. I also observed ELUX vapes on display on the counter (discussion with Trading Standards prior to visit to be aware of these and to report as necessary) This was reported to PC 3336 Shahwaz SHAJIAT following the visit.

- 12. I refer to exhibit AP5 which is my written notes from the visit on 01st September 2022. It is noted that Ravidu Hewa WADUGE did not sign the visit sheet before I left but was present as I made notes and we did discuss the content as it was being written.
- 13. I refer to exhibit AP6 which is a photograph of the ELUX vapes on display at the premises which I believed to be counterfeit

Continuation of Statement of:

- 14. I refer to exhibit AP7 which is an email to PC 3336 Shahwaz SHAJIAT who works with Nottinghamshire Trading Standards on 01<sup>st</sup> September 2022 reporting my findings in relation to the ELUX vapes which I believed to be counterfeit
- 15. I refer to exhibit AP8 which is a copy of the second written warning letter sent to Ravidu Hewa WADUGE on 02<sup>nd</sup> September 2022 formally identifying the conditions that were not met and requesting that these are addressed within seven (7) days.
- 16. I am aware of a visit to Buy and Save by Nottinghamshire Trading Standards on 06<sup>th</sup> September 2022, whereby a large number of suspected counterfeit vapes and cigarettes were seized.
- 17. Following an email conversation with Phil TAYLOR from Nottinghamshire Trading Standards on 13<sup>th</sup> September 2022, it was agreed that Phil TAYLOR would instigate a review by formally completing a Notice of Representation, which would be submitted to Ashfield District Council. I refer to this email as exhibit AP9.
- 18. As an update I spoke to Phil TAYLOR by telephone on 21st September 2022, who advised that they are still looking to start the review process, and hopeful it will be done in the next couple of weeks
- On 30<sup>th</sup> September 2022 I emailed Phil TAYLOR and copied in PC 3336 Shahwaz SHAJIAT, asking for an update on where they are with the paperwork and Notice of Representation. I received an email back from Phil TAYLOR on 02<sup>nd</sup> October, stating that they are due to inspect the premises again on Wednesday 05<sup>th</sup> October 2022 with colleagues from Environmental Health, and hope to present more evidence to challenge the license.
- 20. On 05th October 2022 at 11;48 I received a phone call from Phil TAYLOR from Nottinghamshire Trading Standards to say they had completed an inspection at the premises today along with colleagues from Police and Environmental Health. They have seized a quantity of non-compliant vapes plus over twenty (20) bottles of what is believed to be counterfeit vodka. Phil TAYLOR also stated the inspection found 16 packets of cannabis infused confectionary. Phil TAYLOR stated that three large knives were seized from the top of the cigarette counter. Phil TAYLOR stated the number of vapes seized today has not been counted but is expected to be a higher number than the ones seized at their previous visit on 06th September 2022, whereby Phil TAYLOR gave words of advice to Ravidu Hewa WADUGE to say that these were not compliant and should not be sold. I asked Phil TAYLOR when the Notice of Representation is likely to be submitted and he stated that due to the inspection today, and the need for it to be verified as counterfeit, and for evidence to be gathered, this could be another two weeks. I asked if the premises are still allowed to trade, and Phil TAYLOR stated they are.

- On 05th October 2022 I then discussed the Notice of Representation status with Kate 21. ANSTY, County Senior Licensing Officer for Nottinghamshire Police, who has concerns over the time taken to instigate the review. It was decided that we in Nottinghamshire County licensing department would offer to instigate the review, based on visits by myself, and that Trading Standards and Environmental Health would then be invited to add more evidence. I then rang Phil TAYLOR at 12:30 to offer this solution, to which he agreed, and would support the review process. The requested review outcome would be a full revocation of the Personal Licence for Ravidu Hewa WADUGE plus the revocation of the Premise Licence at Buy and Save, 7 High Street, Stanton Hill, Sutton in Ashfield, Nottinghamshire. NG17 3GG.
- On 05th October 2022 at 12:37 I rang Julian ALISON, Senior Licensing Officer, Ashfield 22. District Council, to make him aware of the situation, and that to expect a Notice of Representation.
- 23. On 06th October 2022 I had a telephone conversation with Insp Jon HEWITT, Neighbourhood Policing Inspector for Ashfield who is looking into the potential for a Closure Notice and Closure Order. I explained that we could review now based on the premise licence but that would only potentially take the alcohol sales away and can carry on trading. A Closure Order would need to be triggered by the Local Policing team and authorised at Superintendent level. As part of that process a review would be completed. I advised that until a decision is made on the Closure Notice is made, we would not instigate the review. Insp Jon HEWITT advised me that he would keep me informed and collate facts and evidence before a decision is made.
- 24. On 10th October 2022 a further conversation with Insp Jon HEWITT, Neighbourhood Policing Inspector for Ashfield, confirmed the Closure Notice/Order process is to be initiated and appropriate documentation will be sent to Legal Services once collated and completed.
- 25. On 02<sup>nd</sup> November 2022 an email conversation with Insp Jon HEWITT. Neighbourhood Policing Inspector for Ashfield, confirmed they planned a test purchase operation for 14th November 2022, followed by a search and issuance of a Closure Notice on 15<sup>th</sup> November 2022, with a pre-arranged court date for the afternoon of 17<sup>th</sup> November 2022 to request a Closure Order.
- 26. On 16th November 2022 I submitted an application for the review of a premises licence to Ashfield District Council. The Premise Licence Holder Ravidu Hewa WADUGE was sent a copy to the address shown on file as per the Personal Licence, plus a copy was also emailed to the email address that was supplied at my visit on 01st September 2022
- On 17th November 2022, I was advised that the defence requested an adjournment of 27. the Court hearing for a Closure Order, which has been granted and the hearing will now take

place on 01 December 2022 at 2pm. The effect of this is that the shop must remain closed in the meantime as the court have extended the closure notice

- I have been made aware by a member of County licensing team that at circa 23:45 on 17<sup>th</sup> November 2022, it was observed that the shutters were up, the lights were on and a male wearing a black puffer-style jacket was in the doorway smoking a cigarette. Insp Jon Hewitt has been made aware of this by email on 18<sup>th</sup> November 2022 for further investigation.
- 30. On 18<sup>th</sup> November 2022 I had a telephone conversation with Julian ALLISON, Senior Licensing Officer for Ashfield District Council. Julian ALLISON stated that the annual premise licence fee had not been paid, and that they had previously sent a reminder to the premises to give 21 days to pay, otherwise the premise licence would be suspended. This period is due to expire on 21<sup>st</sup> November and Julian ALLISON does not expect the fee to be paid so, by default the premise licence will be suspended until payment is received.
- 31. On 01 December 2022 a Closure Order was issued to Ravidu Hewa WADUGE for Buy and Save, 7 High Street, Stanton Hill, Sutton in Ashfield. NG17 3GG by Mansfield Magistrates Court. This expires at 23:59 on 28 February 2023 and does not allow the premises to trade.
- 32. I also refer to the following documents:
  - AP14 Copy of Closure Order issued by Mansfield Magistrates Court
- AP15 Statement by Inspector Jon HEWITT, Ashfield Neighbourhood Policing Commander. Please note the reference included on the statement also stating the store name as 'Seven til Ten' which is the previous name of the store, with the same Premise Licence Holder and Designated Premise Supervisor being Ravidu Hewa WADUGE.



I visited Buy and Save on Friday 19 August 2022 at 11:25 with intention of doing a compliance visit with the owner (DPS and PLH) Ravidu WADUGE.

On arrival I was greeted by a female shop worker Latha Fernando Gardi HEWAGE and a male shop worker who identified himself as the shop maanger, Gelhore RAYMOND.

Compliance tests were still done in the absence of the owner, who was contacted via telephone by one of the staff and I talked to him to say I would be doing a compliance visit.

Failings identified which are in breach of Premise Licence conditions:

CCTV not accessible by staff, so could not verify retention period. It is noted they have a decent system with cameras in and outside

Challenge 25 posters not on display

Premise Licence summary not on display

Staff training documents not available and Gelhore RAYMOND stated he has not signed anything for staff training, indicating that training has not been documented.

Following from that I looked around the store and in the storerooms and lots of spare stock in there but no cigaretted. I asked Gelhore RAYMOND where they kept cigarettes and he said it was kept at the owners house or at his Aunts house. Gelhore did not disclose the addresses.

I looked behind the counter and in the cupboard where they sell cigarettes. I noticed on the top right side of the cupboard some blue packets of cigarettes. I took these out and there were 9 sealed packets of the Richmond King Size 20's as per pictures attached. I asked why they were there and Gelhore RAYMOND indicated he did not know. I said these are not to be sold and to remove immediately which was done in my presence. I stated that I would be reporting the shop to Trading Standards and there will be consequences from that.

I will issue a warning re compliance breaches if you can deal with the cigarettes, which I believe to be illicit.

Let me know if anything comes of it.

Please take action to correct the above immediately upon your return from holiday. Please check your CCTV system to ensure there is enough memory capacity to record 31 days. It may also be an option to use 'motion-only' settings on certain cameras instead of recording 24hrs, as this may free up extra storage space on the system.

Police recommend daily best practice regarding CCTV is shown below:

- Check all cameras are working, reporting any faults to the CCTV installer and inform us on the email address helow
- Check the system date and time is correct, and amending as applicable
- Check the retention period of footage for all systems to ensure past footage is available to be viewed in line with your Premise Licence, ideally 31 days as a minimum

I would like to remind you of the conditions on your licence as below.

### Annex 2 - Conditions consistent with the Operating Schedule

- A CCTV system with recording equipment shall be installed and recorded on the plan appended to the licence. The system shall be installed prior to the premises carrying out licensable activities and maintained in accordance with the system.
  - All recordings used in conjunction with CCTV shall:
  - Be of evidential quality
  - Cover the point of sale, and entrance and exit
  - Indicate the time and date
  - Be retained for a period of 31 days
  - Sufficient staff will be trained to use the system
  - The original images will be made available for inspection immediately upon the request of Police. officers, or other authorised officers.
  - Copies of recordings shall be provided in a format which can be viewed on readily available equipment without the need for specialist software.
- All staff engaged or to be engaged in the sale of alcohol on the premises shall receive the following training in age restricted sales:
  - Induction training which must be completed and documented prior to the sale of alcohol by the staff member.
  - Refresher/reinforcement training at intervals of no more than 6 months.
  - Training records will be retained at the premises for a minimum period of 12 months and available for inspection upon request by a Police Officer and/or authorised person
- 3. A Challenge 25 scheme shall operate at the premises. Any person who appears to be under 25 years of age shall not be allowed to purchase alcohol unless they produce an acceptable form of photo identification. (e.g. passport, driving licence, Military ID or PASS accredited card).
- 4. Challenge 25 notices shall be displayed in prominent positions throughout the premises

Section 136 Licensing Act 2003 makes it a criminal offence to breach the conditions of your premise licence. Action for a breach of this section of the act can be taken against all/any of the following:

- (1) The premise licence holder
- (2) The Designated Premise Supervisor
- (3) Any person who is facilitating the breach

The penalty for breach of Section 136 Licensing Act 2003 can be sentenced to a fine of an unlimited amount and/or 6 months' imprisonment. The court also has power to use ancillary orders such as surrender of a personal licence.

As you are aware, the Responsible Authorities consider effective and responsible management of the premises and adoption of best practice in the leisure industry to be amongst the most important control measures for the achievement of all the licensing objectives.

The primary responsibility for controlling licensable activities lies firmly with the management of the premises. As you are the Designated Premises Supervisor that responsibility falls to you.

The Police request that you look at your operating procedures and put systems in place, which will assist in preventing any further breaches and offences.

It may also be an option to use 'motion-only' settings on certain cameras instead of recording 24hrs, as this may free up extra storage space on the system.

Police recommend daily best practice regarding CCTV is shown below:

- Check all cameras are working, reporting any faults to the CCTV installer and inform us on the email address
- Check the system date and time is correct, and amending as applicable
- Check the retention period of footage for all systems to ensure past footage is available to be viewed in line with your Premise Licence, ideally 31 days as a minimum

I would like to remind you of the conditions on your licence as below.

### Annex 2 - Conditions consistent with the Operating Schedule

A CCTV system with recording equipment shall be installed and recorded on the plan appended to the licence. The system shall be installed prior to the premises carrying out licensable activities and maintained in accordance with the system.

All recordings used in conjunction with CCTV shall:

- Be of evidential quality
- Cover the point of sale, and entrance and exit
- Indicate the time and date
- Be retained for a period of 31 days
- Sufficient staff will be trained to use the system
- The original images will be made available for inspection immediately upon the request of Police officers, or other authorised officers.
- · Copies of recordings shall be provided in a format which can be viewed on readily available equipment without the need for specialist software.
- All staff engaged or to be engaged in the sale of alcohol on the premises shall receive the following training in age restricted sales:
  - Induction training which must be completed and documented prior to the sale of alcohol by the staff
  - Refresher/reinforcement training at intervals of no more than 6 months.
  - Training records will be retained at the premises for a minimum period of 12 months and available for inspection upon request by a Police Officer and/or authorised person
  - 3. A Challenge 25 scheme shall operate at the premises. Any person who appears to be under 25 years of age shall not be allowed to purchase alcohol unless they produce an acceptable form of photo identification. (e.g. passport, driving licence, Military ID or PASS accredited card).
  - 4. Challenge 25 notices shall be displayed in prominent positions throughout the premises

Section 136 Licensing Act 2003 makes it a criminal offence to breach the conditions of your premise licence. Action for a breach of this section of the act can be taken against all/any of the following:

- (1) The premise licence holder
- (2) The Designated Premise Supervisor
- (3) Any person who is facilitating the breach

The penalty for breach of Section 136 Licensing Act 2003 can be sentenced to a fine of an unlimited amount and/or 6 months' imprisonment. The court also has power to use ancillary orders such as surrender of a personal licence.

The Responsible Authorities consider effective and responsible management of the premises and adoption of best practice in the leisure industry to be amongst the most important control measures for the achievement of all the licensing objectives. The primary responsibility for controlling licensable activities lies firmly with the management of the premises. As you are the Designated Premises Supervisor that responsibility falls to you.

The Police request that you look at your operating procedures and put systems in place, which will assist in preventing any further breaches and offences.



- 3. that there has been, or (if the order is not made) is likely to be, disorder near those premises associated with the use of those premises

And that the making of a Closure Order is necessary to prevent the occurrence of such future serious nuisance, similar behavior or disorder.

The Court in issuing this Closure Order prohibits anyone from remaining on or entering BUY AND SAVE, SEVEN TIL TEN, 5-9 HIGH STREET, STANTON HILL, SUTTON IN ASHFIELD, NOTTINGHAMSHIRE NG17 3GG at any time except:-

If anyone does anything which they are prohibited from doing by this order, they shall be liable to arrest and, on summary conviction, to a term of imprisonment not exceeding 51 weeks or to a fine or both.

I am the local district commander for the Ashfield district. Part of my role is to set the local policing priorities in consideration of feedback from communities and partner agencies; I also consider the core roles of the police to protect life and property, preserve order, preventing the commission of offences and bringing offenders to justice. Within Nottinghamshire these goals are embedded within the organisations vision to 'Make Nottinghamshire a safe secure place to work, live and visit'. For Ashfield the policing priorities currently include dangerous driving, anti-social behaviour and drug dealing. Drug dealing in Ashfield is strongly linked to county lines methodology with children used to deal drugs, moved between localities and violence with knives used to enforce fear. Nationwide county lines offending has been heavily linked with serious violence and murders with many children now imprisoned for murder having been groomed by county lined offenders and ultimately become part of criminal gangs themselves.

Since I have been the district commander for Ashfield one shop in the district has

#### Intelligence linked to premise

Within the past 12 months the following intelligence has been received regarding the store: -

16/10/2021- MACHETES are being sold under the counter to teenagers. A large amount of locals in the area are carrying MACHETES and are actively on the streets with them.

29/01/2022-The shop keeper ... is selling Alcohol to Minors on a regular basis.

02/07/2022-Owners of the Seven till Ten Store Stanton Hill Sutton in Ashfield

Nottinghamshire are selling alcohol to underage females aged between 13 to 14 years old. They are selling 3x cans of beer at 10 and bottles of Vodka. The shop owners are described as Asian males and have baseball bats stored behind the counter.

16/08/2022- the owner of the store sold cannabis from the premises. This happens a lot.

The store is selling laughing gas.

21/08/2022- At the Buy and Save shop Stanton Hill Sutton in Ashfield Nottinghamshire NG173GG the staff are selling vapes and drugs to underage children.

01/09/2022-The Buy and Save shop High Street Starting Hill Sutton in Ashfield Nottinghamshire is selling vape products to 13 and 14 year old children.

### Police incidents at premise

As evidenced in officer statements on the 5<sup>th</sup> October 2022 during a visit with trading standards machetes were located behind the till. Also recovered was what is believed to be cannabis infused sweets. On 21<sup>st</sup> November 2021 a test purchase operation was run sale of kitchen knife made to a 15 year old child. This visit was conducted jointly with

trading standards who both on this visit and previously seized unlawful vapes. What is believed to be counterfeit alcohol was also seized. My officers have assisted trading standards on a number of further visits with illegal vapes located each time. On 14th November a further test purchase operation was run with a sale made for a

### **Knife Crime Concerns**

vape to a 16 year old girl.

Nottinghamshire Police's knife crime strategy published in 2018 recognised the local and national concern held by the public and media in relation to knife crime which was increasing levels of fear in citizens. With media outlets regularly reporting violent crimes involving knives, and knife enabled crime increasing both within Nottinghamshire and nationally positive action was required to make communities safer and rebuild public confidence. At this time the Home Secretary affirmed knife crime as a national priority. The strategy aims to break the cycle of knife crime by focusing on four main stands; these being: -

Identification and management of risk (1)

Developing Resilient spaces (2)

Communications and behavioural change (3)

Communities and the third sector (4)

Within the evidence offered there is evidence of the shop selling knives to underage children, intelligence of the same and knives have been found behind the counter. Whether positioned for sale or self-defence as offered there is, I believe, a clear likelihood of these weapons ending up in the public domain and being used in criminal offences. Considering this and the disregard of previous agency interventions a premise closure would serve to keep the public safe and specifically with regards to the Nottinghamshire Police knife crime strategy would manage an identified risk at an early

stage (1), prevent the store posing a danger to the public (2), send a clear message to the store owners and wider community that knife crime will not be tolerated (3) and show local communities their concerns will be acted upon (4). Drug dealing and specifically county lines involving knives is a priority within Ashfield so local stores putting knives in children's hands is putting their lives at risk.

#### Drugs and alcohol

I do not intend to delve into the potential harms caused by the sale of illegal E-cigs, the evidence of trading standards officers will provide this. Numerous have been raised for the store selling vapes and alcohol to children. Again the dangers to health regarding counterfeit alcohol will be given by trading standards but the sale of both to minors is not in accordance with the public health strategy and only serves to start the path towards substance misuse. Beyond the actual criminal offences being committed by having cannabis within the store and supplying anybody with this let alone children research suggests ongoing drug use by children leads to physical health problems. mental health problems, poorer exam results and acting out of character and not considering personal safety.


#### Incidents around Store.

Nottinghamshire Police use IBM Power BI which allows me to utilise a data driven approach to tasking across the district. Using this data I can confirm in the past 12 months in the area shown the map below, the area around the store, there have been 368 incidents reported to the police. As the map shows the area around the store is a hot spot for reports

Of these reports 48 were of anti-social behaviour. These consist of children playing loud music and drinking alcohol on the local park, children on motorbikes, children in drink fighting, children smoking cannabis on the street and knives found by members of the public on the street.

### **Summary and Closure Requirements**

Premise closures can be made should the court be satisfied that a person has or (if order not made) is likely to engage, in disorderly, offensive or criminal behaviour on the premise. Ongoing intelligence states offences of supply drugs are being undertaken. The police have found what is believed sweets with cannabis within the store. The store has sold knives to children and have knives behind the counter to use in self-defence. Whilst it could be argued behind the counter is a private place and no offences are committed, I would draw the courts attention to the likelihood of criminal behaviour, if not closed I believe it is only a matter of time before somebody is seriously injured or killed due to the behaviour of those operating the premise.

Further reasons for a closure order to be granted are that the use of the premise has resulted, or (if the order is not made) is likely to result, in serious nuisance to members of the public. A similar provision for disorder associated to the premise is also included. I believe the selling of alcohol by the premise is linked to anti-social behaviour in the

near locality. Intelligence received supports this and community feedback form both members of the public and local Cllrs state children are obtaining alcohol from the store and acting in an anti-social manner. The link between alcohol and disorder is well established and the dangerous mix between alcohol and drug supply and weapons by the store is putting local communities at risk.

For these reasons a Premise Closure notice was issued and following a hearing at Mansfield Magistrates court a closure order was made on 1st December closing the store for 3 months. Since the closure I have noted from comments on the forces social media feed and those from local media outlets that it appears well known the store would sell vapes and alcohol to children with many comments seemingly from those under 18 expressing both these prior sales and uncertainty of where they may now source such items.

My request would be that any subsequent licencing review the stores licence is revoked. The store has repeatedly shown itself not to be fit and proper, will not sell in accordance with the law and has not heeded numerous warnings.
